

**BLEDSOE DIESEL LIMITED 2 YEAR TRANSMISSION WARRANTY**  
**Manufacturers parts hold their own warranty / This warranty is non-transferable**

**LIMITATIONS AND EXCLUSIONS:**

- A. Warranty coverage is VOID if vehicle has been altered or modified in any way.
- B. BDP Assumes workmanship warrantable issues pertaining to Transmission failure. We do not assume responsibility of Manufacturer defect as the manufacturers have their own warranty in place that we will not exceed nor alter.
- C. This warranty does not cover damage resulting from abuse, low fluid level, incorrect fluid, unreasonable use, mistreatment, neglect, negligence, or accidental breakage.
- D. Trucks with tires that are larger than 35" will not be warranted unless proof of gear swap is provided.
- E. Shaft Breakage of any kind is not warrantied.
- F. Bledsoe Diesel & Performance, LLC will not be liable for death or injury to a person or damage to property; or any incidental or consequential damages resulting from the use of it products. Such damages include, but not limited to transmission, engine, engine components or other associated parts, cost of capital, telephone, and freight charges, sales tax on any parts or repairs, or any customer claims of damages.

**CORE POLICY**

Transmission/Transfer Case Charges: *Overview* Like-for-like cores returned without visible holes or cracks in the case, not missing any parts, drained and secured (if straps were provided) to the undamaged supplied skid will receive full credit, otherwise these charges may apply:

**CLAIMS PROCEDURE:**

- A. In the event your vehicle needs repair, you must get it back to us for inspection.
- B. There is NO provision for rental car, towing, motel, meals, travel, etc.
- C. This warranty is between the original purchaser and Bledsoe Diesel & Performance, LLC and is not transferable.
- D. If Bledsoe Diesel & Performance should elect to replace your unit, the replacement unit shall be considered to be a repair and does not extend the warranty beyond that issued with the original unit.
- E. The warranty does not cover fluid or any miscellaneous shop charges. The customer will be responsible for any such cost incurred, that are not covered by the warranty.

**APPLICABLE LAW AND VENUE FOR LEGAL ACTION:**

This limited warranty allocates the risks of product failure between Bledsoe Diesel & Performance, LLC and the original owner as authorized by uniform commercial code and the applicable laws. In event of any legal action to enforce the terms of the warranty, the customer agrees that the laws of the state of Texas shall govern such action, that the courts of the state of Texas shall have exclusive jurisdiction for such actions, and the venue shall be Lubbock County, Texas.
